

HYDROCLEAR LIMITED LIFETIME WARRANTY - Effective as of 10/1/2021 Cardinal FG Company warrants to the Original End User(1) that its HydroClear coated glass will be free of visible corrosion and staining on the coating surface for the life of the product when installed in a shower or bath application expressly conditioned upon the Original End User satisfying all of the following requirements:

- 1. The product is registered at www.cardinalcorp.com within thirty (30) calendar days of completed installation;
- 2. The product is properly maintained for the life of the product according to Cardinal FG Company's instructions; and
- 3. The warranty claim is submitted to Cardinal FG Company through electronic filing of a HydroClear Warranty Claim Form.

This warranty does not cover scratches, chips, breakage, damage from improper installation or other causes outside Cardinal FG Company's control, or if the product is altered in any way. This warranty is not transferable or assignable, and does not apply to any applications other than shower or bath.

This warranty shall be null and void in the event of any of the following circumstances:

- Use of abrasive cleaners such as, but not limited to, Comet®, Ajax® or CRL Sparkle® on the product.
- Use of acids, alkalis or other strong chemicals on the coated surface.
- Use of abrasive pads or brushes on the coated surface.
- Use of scrappers, razor blades or other sharp tools on the coated surface.
- Failure to follow Cardinal FG Company's instructions regarding the product.

In the event that the HydroClear is found defective by Cardinal FG Company, Cardinal FG Company will, at its sole option, either replace the product or refund the original glass cost only. IN NO EVENT SHALL CARDINAL FG COMPANY BE LIABLE FOR COSTS RELATED TO THE REMOVAL OF FAILED PRODUCTS, THE INSTALLATION OF REPLACEMENT PRODUCTS, OR FOR ANY SPECIAL, INCIDENTAL, INDIRECT, RELIANCE, PUNITIVE, OR CONSEQUENTIAL LOSSES OR DAMAGES INCLUDING, BUT NOT LIMITED TO, LOSS OF USE, LOSS OF ENJOYMENT, OR LOSS OF BUSINESS. The Original End User shall make available to Cardinal FG Company for inspection any product that the Original End User claims to be defective or subject to a claim under this warranty in its installed application. The warranty is null and void if the Original End User fails or refuses to make available the alleged defective product for inspection by Cardinal FG Company as set forth above within a reasonable time after submission of the warranty claim, which in no event shall be more (30) calendar days after claim submission. Additionally, the warranty shall be null and void if the Original End User alters, removes, destroys, or disposes of the product from its installed application (i.e., from any end product or installation/ glazing system) before Cardinal FG Company completes its inspection or review of the same.



EXCEPT AS EXPRESSLY SET FORTH HEREIN, CARDINAL FG COMPANY DOES NOT MAKE AND HEREBY DISCLAIMS ANY AND ALL REPRESENTATIONS OR WARRANTIES, WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE, REGARDING ANY PRODUCTS PROVIDED OR SOLD BY CARDINAL FG COMPANY INCLUDING (WITHOUT LIMITATION) IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR USE, NONINFRINGEMENT, OR RELATED TO ANY OTHER MATTER.

THIS WARRANTY SHALL BE THE SOLE AND EXCLUSIVE REMEDY FOR ANY AND ALL CLAIMS RELATED TO THE PRODUCT.

Maintenance Instructions for HydroClear Proper maintenance of the HydroClear product requires hand cleaning. When used in shower and bath enclosures, use a soft rubber squeegee to remove water after each use to keep HydroClear glass looking better between regular cleanings. This will also make regular cleaning easier. Regular cleaning shall be in accordance with the following recommendations:

- Thoroughly wet the surface of the glass with plain water to remove surface contaminates.
- Use a soft cloth or a sponge (Magic Eraser® is also permitted) and one of the commercially available glass cleaners listed below to clean the glass. After cleaning, rinse thoroughly with water and dry. A soft rubber squeegee or clean cloths may be used to dry the glass. Frequent cleaning of the glass is recommended.
- Commercial cleaners such as Clorox® Glass Cleaner, Fantastik® Cleaner, Lysol® Bathroom Cleaner, Mr. Clean® Bathroom Cleaner, Invisible Glass® Cleaner, Sprayway® Ammonia Free Glass Cleaner, Tilex® Shower Cleaner, Windex® Ammonia Free Glass Cleaner, Windex All Purpose Cleaner with Vinegar, Soft Scrub® All Purpose Cleanser and Scrubbing Bubbles® Shower Cleaner are acceptable. Alternatively, a mixture of 50% plain water and 50% white vinegar may be used.
- Products not listed herein shall not be used on HydroClear glass.Los productos no incluidos en la presente no se deben utilizar sobre el vidrio HydroClear. Footnotes:
- (1) Original End User means someone who purchases HydroClear and installs the product in their residence or other property that they own, or someone who contracts through a licensed remodeler or contractor for the purchase and installation of HydroClear for their residence or other property that they own, or the first owner of a residence or other property where HydroClear has been installed as a new installation.
- (2) HydroClear is warranted to exhibit no more than 1% haze during the period of this warranty.
